After the molding material is cured, the ferrite body of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

The responsibility for the applicability of customer specific products and use in a particular customer design is always within the authority of the customer. Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component or body.
