





After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

- The solder profile has to be complied with according to the technical wave soldering specification, otherwise this will void the warranty.

 be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
