



# **RATINGS AND CHARACTERISTICS CURVES** ( $T_A = 25 \, ^{\circ}\text{C}$ unless otherwise noted)








Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current

Fig. 3 - Typical Instantaneous Forward Characteristics




Fig. 4 - Typical Reverse Characteristics


