









## **Recommended Land Pattern: [mm]**

#### Soldering:

- . The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.
- · All other soldering methods are at the customers' own risk.
- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the part, resulting in avoid of the warranty.

#### **Cleaning and Washing:**

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire

## Potting:

recommend a manual inspection after potting to avoid these effects.


### **Storage Conditions:**
