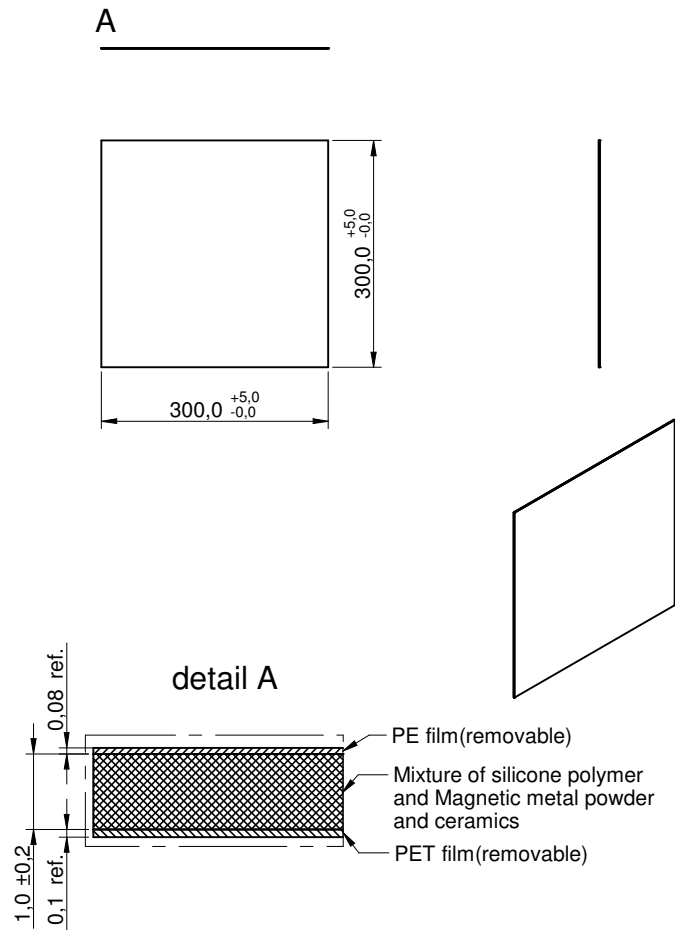

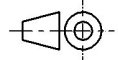

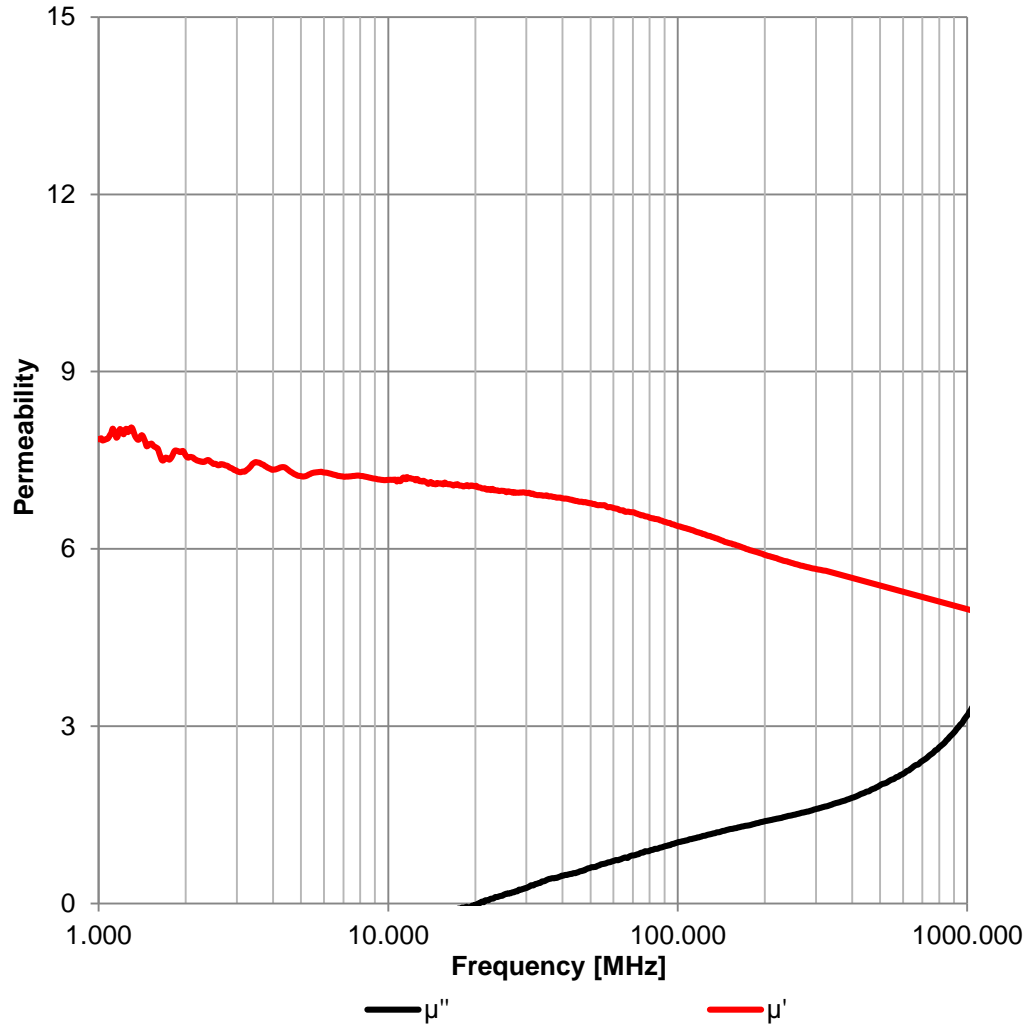

Permeability vs. Frequency:



6. Product Life Cycle


