


Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage






Fig. 4 - Maximum Thermal Impedance ZthJC Characteristics


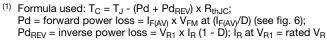




Fig. 6 - Forward Power Loss Characteristics


