General product information

The BST-Exd series cable glands are metallic and are intended to terminate non-armoured cables into Ex db or Ex tb enclosures without compromising the explosion protection provided by the enclosures in accordance with relevant codes of practice.

The model BST-Exd-SS provides single seal. The structure consists of a fittings body (metal), a pressing nut (metal), a circular sealing ring (non-metal) and two flat sealing gaskets (non-metal). Provides M and NPT threads for connection.

The model BST-Exd-DS provides double seal. The structure consists of a fittings body (metal), a pressure nut (metal), two circular sealing rings (non-metal) and two flat sealing gaskets (non-metal). Provides M and NPT threads for connection.

As The cable glands of BST-Exd-SS, model BST-Exd-SST provides an addition sealing nut for connecting with Flexible Conduit.

The model BST-Exd-SSF consists of a fittings body (metal), a pressing nut (metal), a circular sealing ring (non-metal), a flat sealing gasket (non-metal) and a parking barrel for encapsulation. Provides M and NPT threads for connection.

As the cable glands of BST-Exd-SSF, the model BST-Exd-SSFT provides an addition sealing nut for connecting with Flexible Conduit.

Suit for explosive atmosphere zone 1, zone 2, zone 21 and zone 22; applicable to IIC gas zone and IIIC dust zone.
